#### **Terms and Conditions**

#### **Order Fulfillment**

Orders are filled "first come, first served" as quickly as possible, with consideration for factors such as backlog, inventory, and business hours. Items unavailable at the time of the order will be placed on backorder status. Once availability is determined, dealer will be notified of the estimated backorder release date. Dealers may cancel a backorder or unshipped order at any time.

## Shipping

Unless otherwise specified, orders will ship via a carrier (e.g. UPS®) and at a service level (e.g. Ground) selected by Forward Gear. Dealers may specify a carrier preference and/or service level, however, such specification may affect the cost of shipping. Forward Gear accepts no responsibility for loss, damage, or delay once items are FOB shipping point.

## **Freight Allowance**

Orders over \$500 will ship freight prepaid (carrier and service level determined by Forward Gear). If a carrier or service level is specified by the dealer, the prepaid freight charges will be deducted from the final freight fee, if higher.

## **Damage Claims**

Damage incurred during shipping is the responsibility of the carrier. Damage claims should be processed between the dealer and the carrier. Forward Gear will assist in the claim process as possible and will attempt to expedite shipment of replacement items.

### **Returns**

Returns are accepted in any condition, at any time. Returned items will be inspected and credit issued as per the following schedule:

Condition	Credit
As-new in original packaging	100%
In original packaging, not as-new, resalable	50%
No packaging, as-new	50%
No packaging, not as-new, resalable	25%
Not resalable	0%

Return shipping is the responsibility of the dealer. Credit is issued in the form of a Forward Gear account credit, unless otherwise arranged.



#### **Recommended Retail Price**

The Recommended Retail Price (RRP) for items is intended to encourage a profitable sale within the realities of the marketplace. RRP does not reflect or include incidental costs such as freight, taxes, or other dealer/retail costs. Actual retail prices may vary. RRP is subject to change without notice.

#### **Minimum Advertised Price**

The Minimum Advertised Price (MAP) floor is 10% below the Recommended Retail Price (RRP). If an advertised price falls below this floor, the offending dealer risks revocation of authorized status.

#### **Wholesale Price**

The Wholesale Price is the standard price charged to authorized dealers (independent of discounts).

#### **Discounts**

Forward Gear is conscious of the dynamic and aggressive retail environment. We research "book" and "street" prices for comparable or identical products, and establish pricing intended to help our dealers remain profitable and competitive. However, to provide additional opportunity to build profit, we offer the following discounts:

- Prepaid orders receive a 2% discount.
- Orders placed on credit terms receive a 2% discount if paid within 10 days of the invoice date.

Dealers that meet certain order levels receive discounts as per the following schedule:

Order Level	Discount
\$2,500 to \$14,999.99	2%
\$15,000 to \$29,999.99	5%
\$30,000 to \$49,999.99	10%
\$50,000 +	Negotiated discount %

Single orders that meet any of the above levels will receive the associated discount.

Every six month period ending in March and September, Forward Gear reviews each dealer's cumulative order total. If the total falls into any of the above levels, the associated discount will be applied to all orders placed in the following six month period.

Order level discounts do not apply to items already discounted due to promotional pricing, closeout status, or other price reduction mechanism.



## Warranty

Forward Gear prides itself on the quality of the products in the Forward Gear family and is committed to supporting those products with prompt warranty attention. If an item needs to be returned due to a warranty issue, the dealer must complete and submit a Warranty Claim Form. Once qualified as a warranty issue, a Warranty Claim Number will be issued. Items returned for warranty reasons must be accompanied by their claim number.

Forward Gear shall use our best efforts to obtain from each manufacturer, in accordance with the manufacturer's warranty the repair or replacement of goods that may prove defective in material or workmanship. The foregoing constitutes the exclusive remedy of the buyer and our sole obligation. Except as to title THERE ARE NO WARRANTIES, EITHER WRITTEN, ORAL, IMPLIED OR STATUTORY, RELATING TO THE GOODS SOLD TO BUYER BY US AND NO IMPLIED STATUTORY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE SHALL APPLY.

- f) Forward Gear reserves the right to change these terms, and any other terms, conditions, policies, pricing, or procedures at any time, without notice.
